

Terms of Use
Effective November 5th, 2010

This Terms of Use ("TOU") describes the terms and conditions for your access and use of the rvchassisparts.com site and any related sites in the RVCHASSISPARTS.COM domain (the "Website") owned by RVCHASSISPARTS.COM, a Michigan Company ("RVCHASSISPARTS.COM", "we" or "us"). Your use of the Website constitutes your acceptance of the TOU. If you do not agree to the TOU, do not use the Website. We may change the TOU at any time without notice; modifications will be included in the TOU. It is your responsibility to check the TOU from time to time for modifications.
